Dear Minister Mitchell,

Re: Request for clarification from the NSW Government on its measure of Return on Investment of \$8m of capital works through community preschools in 2018

The Australian Childcare Alliance (ACA) NSW applauds the NSW Government for its consistent commitment to assist in increasing the supply of affordable early childhood education and care capacity through community preschools.

Although ACA NSW is not asking for any withdrawal of the NSW Government from such a commitment, we seek your clarification about how you would measure the return of investment of the corresponding taxpayer contributions given.

As you know, the NSW Government has made \$10m available to the community preschool sector each year via the Start Strong Capital Works Grants Program for some time now. In 2018, 17 existing community preschools were successful in receiving about \$8m of the \$10m annual allocation. And an estimated 708 new places are anticipated to have been created. In context, these 708 new places represent 0.002% of the 299,405 already approved number of places.

Would you be able to share with ACA NSW a copy of example report(s) produced by the NSW Department of Education that:

- (a) statistically monitor how many of these newly created places each year become occupied; and
- (b) outline, if any, the Government's policies and expectation(s) on its Return on Investment of taxpayer contributions through the Start Strong Capital Works Grants Program.

We look forward to your response. And thank you in anticipation.
